Roy L. Sours, 78, former representative and official with the Iowa Department of Agriculture, died in Charles City, Iowa, December 15, 1961.

Dr. Raymond J. Chadwick, 55, president of Iowa Wesleyan College, died in New York, New York, November 8, 1961.

J. N. "Ding" Darling, 85, famed Iowa cartoonist and leader in the battle for conservation of natural resources, died in Des Moines, Iowa, February 12, 1962.
