If the by-laws change to allow electronic voting passes at the ACRL business meeting on October 22, online voting for next year's officers will open Friday, October 23 and will close at Noon on Thursday, November 5, 2009. It will take place on the ILA Website. ILA/ACRL Members will be notified via email when the voting has opened. The email will include a link to the online voting booth and the password.

Prior to the ILA Conference, it is very important that you visit the ILA website and login with your user name and password. If you have never logged in before, login with your first and last name, ALLCAPS, No Spaces (e.g. JANEDOE) and ILA is the password. The system will force you to change the password and you will have the option of changing your user name.

If you prefer, paper ballots will be available on request from Mary Iber, Chair of the Nominations Committee. Collective Advocacy: Engaging Public Libraries in the Open Access Movement

Every year taxpayer dollars support millions of dollars of research published in expensive journals that only larger research libraries can afford. Efforts to change this traditional scholarly publication model have culminated in the open access (OA) movement. Open access provides everyone with free, immediate, and permanent access to scholarly research. It is clear that academic libraries have much to gain from the success of the OA movement. But what do public libraries and smaller academic libraries stand to gain from expanded access to taxpayer-funded research? OA advocates will introduce open access concepts, emphasize benefits for public libraries, and engage participants in a conversation to strengthen public library involvement in the OA movement and intensify advocacy across library communities.

Luther College's Preus Library will celebrate its 40th anniversary during a Homecoming weekend celebration this fall.

Can I check out a Bicycle?

If you go to Preus Library at Luther College, the answer is yes! As a response to student suggestions and requests for alternative transportation on campus the Luther Bike Share program was created in April 2008. The college purchased eight bicycles for the Bike Share's first year of operation. The program is a collaboration between Luther's sustainability initiative and Wellness program.

The program operates from Preus Library on campus, where students swipe their Co-Curricular Activity Fee (CAF) card to check out a bicycle, free of charge, for the day. Currently, the Bike Share program consists of five bright yellow single-speed bikes and three new multiple-gear bikes. The bikes are stored outside of the library. Lock keys and helmets are available for check out from the library circulation desk. Users are required to sign a liability waiver form on file before they can participate in the program.

Bikes are due each day by the time the library closes. Checkouts will not be possible on days the library is closed. A late fine of \$10 will be charged if a bike is not returned prior to closing. The program was well-received on campus with 250 checkouts during the first two months. During the 2008-09 academic year, all eight of the bikes have been checked out a total of 1.291 times!
