# **Drake University**

# Scott Community College

Scott Community College library's staff has changed almost completely in the past few months. This spring, we were joined by Sara Kutzli and Kelly Kanzaki and, this July, Melita Tunnicliff started work with us.

Last spring, we hosted lectures for the local SCENE (Sustainable City Empowered Network for Education) program, which aims to educate citizens about environmental topics. With subjects as diverse as water conservation in Des Moines, environmentally themed poetry, and the effect climate change had on ice age short nosed bears. Lecture attendance rose steadily, peaking at over 70 people. We look forward to another successful series this coming year. Recently, we purchased a number of movies by ASL films, a deaf owned and operated production company. Our ASL instructors are excited about the addition and we look forward to frequent use for these items.

# **Morningside College**

In the past year there have been a lot of changes at the Hickman-Johnson-Furrow Library of Morningside College including a number of personnel changes. Jim Fisk has moved with his wife to New Mexico, and Adam Fullerton has been named Library Director. Holly Petersen joined the team in the fall of 2013 as the new Reference & Instruction Librarian. Holly is an Orange City native who graduated from Northwestern College with a BA in Literature & Philosophy and received her MLIS from the University of Iowa in 2013.

A number of non-personnel changes have been made as well. The HJF has renewed for a second year with EBSCOhost's Discovery Services, and has subscribed to a number of new Gale databases. The building itself is undergoing a renovation that is part of a larger campus construction project. The renovation is scheduled to be completed in October. The HJF has completed the digitization project of the college newspaper, "The Collegian Reporter", and it is now available online. The HJF is also working with the Sioux City Public Museum to digitize and create an online database for the college's yearbooks using the software Omeka. The HJF Virtual Lecture Series is back for a second year. Last year's speakers included: Adi Kamdar of the Electronic Frontier Foundation, Prof. Jeff Jarvis of the City University of New York, Dr. Peter Singer from Princeton University, bestselling author Amy Stewart, Dr. Noam Chomsky from Massachusetts Institute of Technology, and open access expert from Earlham College Dr. Peter Suber.

# **Loras College Library**

We've been working on implementing our strategic plan for the past 2  $\frac{1}{2}$  years. It has five primary goals – our collections, funding, Library awareness, our services, and our spaces. Over the past year or so, we've been working on the following:

#### Collections:



Part of our plan was to weed. In summer 2013, we weeded JSTOR periodical titles along with short runs of miscellaneous periodical titles. We almost filled the dumpster but we ran out of time before school started!

In summer 2014, we weeded our first and second floor collections. We started with a list of items that had not circulated or been used in-house for the past 20 years and were older than 20 years old. The librarians evaluated those items on a title by title basis by working 2 hours a day every day from June 1 - July 31. Student employees withdrew and boxed up 14 pallets each holding 40 boxes of books.




Our student employees also created over 5,500 records in the Library catalog. Loras has a collection of theses and the only access point we had for these were via shelf-list cards so we updated that access.

We received the papers from Dubuque author, Thomas Gifford, who wrote as Thomas Gifford, Thomas Maxwell, and Dana Clarins. His most well-known book is probably Assassini published in 1990.

#### Funding:

We prepared a presentation that the library director gave to the Administration Team in January 2014. We covered the positive effects that the library has on recruitment, retention, student achievement, and philanthropy. We have re-used that information as a presentation for the 175th Legacy Symposium at Loras, for an IPAL presentation, in our faculty newsletter, in a library display, and in our bathroom ads. This was truly a group project as many of us located articles, two interns helped summarize the articles, the entire staff made constructive comments on the presentation to help emphasize certain points, and two librarians edited the presentation before the director proceeded. While we won't know for a while if the Administration Team will consider additional funding because of this presentation, we felt it was worthwhile to educate them to some of the values of the library that they most likely didn't know.



#### Library spaces:

We surveyed students this spring about library spaces – how they use them, where they like to study, and what kinds of things we need to add. We also did a patron count – we chose one week in March, one in April, and one in May. During those weeks, we counted people in the library and made a chart of where they were seated each hour of the day. We also conducted focus groups and surveys regarding our study rooms so we have plenty of information to digest and share.

#### Library Awareness:

We participated in all of the new and transfer student orientation sessions; we placed articles in the Parent Newsletter that the College puts out 3 times each year; we hosted Thursdays @ the Library with free coffee and treats; we created Homecoming displays that are hung up in the Alumni Campus Center for the honored years; we co-hosted a poetry program with a faculty member honoring T.S. Eliot and local poets; we published a newsletter each semester for faculty; we provided a graffiti wall during finals week along with treats; we also coordinated with the Student Government to provide a 24 hour lock-in the week before finals in the fall and the

spring; we created 4 new READ posters and even arranged for one of our READ poster stars to meet his idol who had written the book he chose for his poster; we created bathroom ads that are placed in each of the 22 stalls in the Library; and last but not least, we had a fairly active Facebook presence.

#### Services:

Our information literacy program has grown over the past few years. We now have a Loras Information Literacy Test (LILT) that we gave to first year students and seniors last year. We increased our instruction from 69 sessions in 2011-12 to 138 sessions in 2013-14. Over the same time period, we increased the number of upper level students we saw from 510 to 1590. Just to keep things interesting, we started this semester short 3 staff positions so we're looking forward to getting new people on staff as soon as possible.

# **Special Libraries**

#### **ACT Information Resource Center (IRC)**

In addition to Jacqueline Snider, senior manager, the IRC has two recently hired librarians. Samantha (Sam) Bouwers joined the company in 2012, and Jim Kelly started this past spring. Sam and Jim are graduates of The University of Iowa, School of Library and Information Science (SLIS). Both are embedded librarians and divide their time between the IRC and other departments within the company.

# **Board Candidates' Biography and Statements**

#### Vice President/President-Elect Candidates:

#### Julia Dickinson

Julia has a B.A. in sociology from DePauw University and an MLS from Indiana University— Bloomington. Prior to becoming Assistant Library Director at St. Ambrose University, Julia held positions in reference and instructional services at Berea College in eastern Kentucky, Illinois Wesleyan University, and Hamilton College in upstate New York. She has been a member of national ACRL throughout her career and served as College Libraries Section program planning co-chair for the 2013 ALA Annual Conference. Julia has been a member of Iowa Library Association and ILA/ACRL since arriving in Iowa three years ago. She has served ILA/ACRL as a member of the Newsletter Committee and as Chair of the Fall Program Committee. Julia currently serves as Member-At-Large on the Steering Committee of Iowa Private Academic Libraries consortium. Julia is a member of the 2012 cohort of Iowa Library Association's Leadership Institute and was awarded a Susan Lerdal scholarship to attend the ILA conference in that same year.

"I would be delighted to become ILA/ACRL Vice President/President-Elect. Routinely, librarians are surveyed for input to better serve a given association's members. Networking and professional development consistently rank as important benefits of membership; respondents also note financial hardship regarding dues and conference attendance. Composing a robust association on such feedback is challenging. Creative problem-solving among ILA/ACRL *Executive Board members, past and present, is exciting. The current Board is generating ideas* to provide networking activities and free or low-cost professional development opportunities outside of conferences. The intention is to add benefits to membership; but there's also hope that such efforts will attract new members. The dilemma is that if everything the association does to demonstrate value to its dues-paying membership is freely available to non-members, the motivation to join the association is weakened. Our chapter is not self-sustaining with merely 148 current members and 100 registrants at the spring conference. So, what is the value of membership? The Executive Board and committees strive to design programs and to collect and distribute information via our communication channels, with mixed results and variable success. What if the Board shifts energy from serving as a delivery mechanism to building collaborative partnerships across Iowa's library organizations? The association coordinated spring conference with IPAL. Our proposed speakers for ILA fall conference were also tapped for keynote addresses. The K12/Higher Ed Ad Hoc Committee and the Nominating Committee cultivated relationships with teacher librarians and library school students, respectively. As Vice President/President-Elect, I will build on the momentum toward an integrated framework. Competition over human and financial resources is counter-productive. They are us; and we are you. If ILA/ACRL is to survive, our collective response to the question, "What's it worth?" must be constructed through exploration of possibilities and articulated commitments to cooperation. Recognition of interdependence is a measure of our value to ourselves. Active participation in and stewardship of ILA/ACRL is of great significance to me, and I offer my candidacy to the membership."

#### Sara Scheib

Sara Scheib is the Sciences Reference & Instruction Librarian at the University of Iowa. An Iowa native, she earned her BA from Beloit College in 2004 and MA in Library and Information Science from the University of Iowa in 2008. After library school, Sara worked as the Emerging Technologies Librarian at Kirkwood Community College and as Assistant Director of the Pella Public Library before returning to the University of Iowa in 2012.
