### Spring Conference

Once again the Spring Conference was a great success thanks to the conference planning committee chaired by Jane Campagna and the local arrangements committee headed up by Mary Anne Knefel. For those who arrived early, the Thursday night gala and tour was a real treat. After dinner at the historic Bricktown Brewery, everyone boarded the Dubuque Trolley for a tour of the three academic libraries that grace the city. With 95 attendees, we had a good turnout for an event on Iowa's east coast. Ralph Elliot, a Connecticut lawyer with First Amendment expertise, provided a keynote address that engendered many questions and ongoing discussion throughout the conference. It was valuable to hear a perspective from outside the profession. Evaluations came back with very positive reactions to the presenters and topics covered. The food even scored well on conference evaluations! Congratulations to everyone participating in the planning and presentation of the conference.

### Strategic Plan

On July 9, the Executive Board met at Cornell College to begin formulating a new strategic plan for our organization. Our goal was to arrive at a set of achievable goals and objectives that would be closely tied to the strategic plan of the Iowa Library Association. This first meeting was taken up with identifying our goals and agreeing on some activities we can undertake in the next two years to advance our organization. We will be making more concrete steps towards this in the next few months. We identified responsibilities for current committees and have recognized the need for two ad hoc committees. ## **Report from ACRL Chapters Council**

There were a good number of hearty Iowans who attended the ALA Conference in Toronto. John Pollitz represented the Iowa chapter of ACRL at the Chapters Council meeting Sunday morning. Here are some points that he took from that meeting.

- At some point the new ACRL website will have a “members-only” section with official documents, white papers, and the complete contents of C&RL News and College and Research Libraries, along with other information aimed at ACRL members.
- C&RL News is always looking for artwork for its front cover.
- Incoming president Tyrone Cannon addressed the group. The theme for his presidency will be partnership; faculty, staff, and community. He also discussed the effort to revise the ACRL strategic plan. He will be sending out information on the strategic plan and asking chapters for comment.
- This fall expect to see the first call for proposals for the 2005 ACRL Conference in Minneapolis. It was mentioned that there is always a shortage of proposals dealing with technical services issues.
- Chapters were encouraged to nominate members for the annual awards.
- Last November in C&RL News (vol. 63, no. 10), there was a report from the “Focus on the Future” taskforce. That group identified seven top issues facing academic libraries. ACRL is asking the chapters to keep the issues alive. They are calling on us to discuss the issues, create local solutions and feed information to ACRL for inclusion in a national white paper. The issues are listed below.

### **Top issues for academic libraries**

1. Recruitment, education, and retention of librarians.
  2. Role of the library in the academic enterprise.
  3. Impact of information technology on library services.
  4. Creation, control, and preservation of digital resources.
  5. Chaos in scholarly communication.
  6. Support of new users.
  7. Higher education funding.
- Finally, three chapters reported on their activities of the last year. The Wisconsin chapter had a particularly interesting idea. They assign a mentor to the scholarship winners to their conferences. This mentor helps the winner meet people and get the most out of the conference.

## **News of the Iowa Public Academic Libraries**

### **Iowa State University**

The ISU Library is pleased to announce that Hilary Seo has accepted the faculty position of Head of Preservation, beginning August 1. Hilary has been the Head of Preservation at Georgetown University Law Center in Washington, D.C.

Kris Gerhard, formerly the ISU Library's Collections Officer has accepted the position of Assistant Director for Technical Services. Ed Goedecken, Humanities Bibliographer, has accepted the additional duties of Collection Coordinator.

The Board of Regents has formally approved promotion to Associate Professor and granting of tenure to Kris Stacy-Bates, Science & Technology Librarian. Also announced was the promotion to Full Professor of Kris Gerhard, Assistant Director for Technical Services and Ed Goedecken, Humanities Bibliographer.

Later this summer the ISU Library expects to open a search for two Social Sciences & Humanities Librarians: a Subject Bibliographer for Fine Arts and an Instructional Technology Librarian.

Bob Sickles, Science & Technology Librarian, has announced his retirement. At 35 years of service, Bob is the Library's longest-serving faculty member.

The ISU Music Library's collection has been fully incorporated into the Parks Library.

The ISU Library's Ingenta Gateway for patron initiated (unmediated) document delivery service is now available to the public.

## **University of Iowa**

The University Archives and the Information Commons in the Hardin Library for the Health Sciences are joining forces to create a new online database with historical information about the university's buildings. The Web site will trace the history of such facilities as Calvin Hall, which was constructed in 1884 and moved across Jefferson Street to its present location in 1905. A timeline has not been set, but archives staff hope to have the first batch of building records online late this summer. Records will include information about the building's date of construction, its name and use history, and selected images. The database will be linked off the archives' Web site when it is released.

The Special Collections Department recently created new space in the form of new compact shelving units added to their basement storage area in the Main Library. The installation replaced four ranges of old shelves with eight new ranges of compact shelving. This addition yields approximately 144 new sections of storage space, amounting to approximately 2016 linear ft. of new shelving for Special Collections. The project enables the Special Collections staff to prioritize a massive shift of materials, spread out collections that are currently severely cramped, and provide space for continued growth. Plans are underway to maximize the use of the space by moving manuscript collections, book collections, and materials in the University Archives to best serve the needs of users of the collections.

The MetaLib Implementation Team is at work preparing MetaLib (Ex Libris) portal software for release to library patrons this fall. The portal, likely to be titled "MyLibrary," will enable cross-database searching and de-duplication of results, patron-specified resource lists, and periodic alerts of new search results.



Central Technical Services has set new records in cataloging materials. Mary Monson, CTS Coordinator, writes:

“During the fiscal year July 2002-June 2003, staff in Central Technical Services cataloged 62,830 new titles and facilitated the batch loading of an additional 5,310 cataloging records into InfoHawk. This is the highest cataloging output recorded in the thirty years I have been informally keeping track for comparison purposes. The 62,830 new titles represent a 26% increase over last year's cataloging output. When you add in the batch loaded records, the total of 68,140 new cataloging records in InfoHawk is a 37% increase over last year. In addition, 124,035 new volumes and pieces were added to the collection. This is a 13% increase over last year. All of this was accomplished while staff juggled a variety of other tasks and special projects.”
