## IAS FALL MEETING GETS BRISKLY UNDERWAY

The Iowa Archeological Society's Fall Meeting began in crisp temperatures under a blue sky September 19 at Iowa Lakeside Laboratory, Lake West Okoboji. About 45 people attended.

Registration was from 10:00 am to noon. During this time several artifact collections from northwest Iowa sites were arranged on tables around the room of Mahan Hall for visitor's inspection. Meanwhile, hot coffee was dispensed as members renewed old acquaintances and established new ones. A video was played showing the construction, still in progress, of the earthlodge in southwest Iowa.

By noon, appetites were well honed for the substantial and very tasty lunch served at the Lakeside Lab's Mess Hall. At sev-

eral large round tables, members stoked up for the afternoon's events.

second series of Workshops began. These Workshops repeated the first series, allowing participants to attend other workshops. Additionally, Deb Z. Baker gave a guided tour of the Lakeside Lab which was recently listed on the National Register of Historic Places.

By 1:15, participants had chosen one of three concurrent Workshops on Arrowmaking with Toby Morrow; Flintknapping with Mark Anderson; or Archaeological Plant Remains with Bill Green. After a mid-afternoon Break, the

Following the Workshops, Bill Green led a discussion regarding recent discoveries of ancient Iowa. A Mill Creek site on a tributary of the Little Sioux River was briefly described. An account was given of a recently discovered gardening area with cultivated rows. Joe Artz has been survey a stretch of Highway 61 that is to be widened to four lanes. A possible southeast Iowa trade network that operated during Hopewell times was noted, with a more detailed account to be available later.

At the end of the day's events, Dick Slattery was presented with a plaque recognizing his many contributions over a long period of time and in spite of the many trials and tribulations of the Iowa Archeological Society.

After the meeting adjourned, a quorum of board members was found to be present and a board meeting was conducted. Minutes for the September 19 Board meeting will be published later.

Sunday morning the Northwest Chapter hosted a field trip to the Double Ditch site, a Mill Creek Village site north of the Wittrock site.

## Minutes of the Iowa Archeological Society Board Meeting May 30, 1992

**Board Members Present:** Bill Anderson, Yvonne Chadek, Kathy Gourley, Sheila Hainlin, Mary Helgevold, Dale Henning, Kris Hirst, Arlo Johnson, Jerry Phillips, Shirley, Schermer, Dave Swinehart.

**Board Members Absent:** Ferrel Anderson, Deb Zieglowsky-Baker, Karole Fuller, Dennis Miller, Roger Natte, Dick Slattery, Dawn Snyder, Steve Lensink (through 1992).

The meeting was called to order by Jerry Phillips at 10:10 am at the State Historical Building, East 6th and Locust Street, Des Moines, Iowa. A quorum was present.

**I. Secretary's Report:** Kathy Gourley stated that the minutes from the March 28, 1992 meeting had been mailed to the Board in late May. Dave Swinehart moved that the minutes be approved; Sheila Hainlin seconded. Motion carried.

**II. Treasurer's Report:** No report

**III. Newsletter Editor's Report:** Sheila Hainlin reported that she could not complete the *Newsletter's* summer issue until she received more articles. Dave Swinehart and Kris Hirst mentioned that they were working on articles. Board members were encouraged to send articles to Hainlin as soon as possible.

### **IV. Archaeology Week Committee:**

Bill Green, chairman of the Archaeology Week Planning Committee, submitted a written report. The Board discussed the current status of Archaeology Week, and the Society's potential role in it. Board members felt that more planning needed to be done before the event could be initiated. The IAS committee Dale Henning (chairman), Dick Slattery, Deb

Zieglowsky-Baker, and Jerry Phillips) will call Bill Green to discuss making a presentation regarding Archaeology Week to the Association of Iowa Archaeologists. Further Board action on this matter was tabled until more information is received.

**V. 1992 Fall Meeting:** Plans for holding the fall meeting at the Iowa Lakeside Laboratory on September 19th were discussed. Use of the facility costs \$100. Dale Henning moved to approve the meeting plans; Yvonne Chadek seconded. Motion carried.

**VI. Journal Editor's Report:** Kris Hirst proposed a number of changes in the *Journal*. If the Board approves, she intends to establish an editorial board, consisting of four assistant editors. These assistants are Deb Zieglowsky-Baker, Robin Lillie, and Linda Forman. Bill Billeck will continue as the book review editor. Hirst would also like to establish an advisory board of 20-30 individuals. These individuals would serve as advisors, and would be listed on the masthead. Five individuals have already agreed to serve in this capacity.

Hirst also proposed adding two sections to the *Journal*. One section is tentatively titled "Profiles in Iowa Archaeology," and would include biographies of individuals who have made a substantive contribution to the field. As an example, Hirst mentioned Cherie Haury's research on T. H. Lewis. Hainlin mentioned that the newsletter has also published biographies. The editors agreed to work together to avoid duplication in this area.

The second new section Hirst proposed is a commentary section. This section would include controversial and non-controversial issues in Iowa archaeology. Hirst suggested featuring the new geomorphology guidelines in the commentary section for the 1993 *Journal*.

Hirst also proposed that the book review section should include Phase III reports. This would allow information contained in the reports to reach a broader audience.

Swinehart asked what materials would have to be taken out of the *Journal* in

order to make room for the newly proposed sections. Hirst stated that she had not considered specific items to be removed.

Hirst also noted the need for a paid editorial assistant. She said that she would like to find grant funds or other outside funding sources for this. The Board agreed that this was an important issue, and all Board members were encouraged to think about seeking grant funds, corporate sponsorship, or accepting advertising in order to fund an editorial assistant position.

The Board then discussed the status of the overdue *Journals*. Jerry Phillips reported that Steve Lensink proposed the following production schedule:

- \* 1990 (Vol. 37) - July 1, 1992, mailing date.
- \* 1991 (Vol. 38) - August 15, 1992, mailing date.

1992 (Vol. 39) - October 15, 1992, mailing date..

Jerry Phillips stated that he would write to Steve Lensink, asking for firm dates. The Board then discussed when each *Journal* ought to be issued. The consensus was that the membership should receive each issue by the end of the calendar year that the issue is dated. Thus, the 1993 issue should be received by December 1993, etc.

Ave Swinehart moved that the proposed changes in the *Journal* be approved. Dale Henning seconded; motion carried.

**VII. Mailings:** Jerry Phillips stated that Deb Zieglowsky-Baker had suggested sending a subscription mailing to libraries. The Board supported this idea, but determined that such a mailing should be delayed until the back issues of the *Journal* have been sent. The Board approved the concept, pending completion of the 1990, 1991, and 1992 issues.

Dale Henning suggested sending outdated copies of the *Journal* to libraries, as a means of encouraging those libraries to become subscribers. Board members were supportive of this idea.

**VIII. Annual Meeting:** Preliminary plans for the 1993 Annual Meeting were discussed. Yvonne Chadek suggested holding the meeting in Des Moines, possibly at the Science Center of Iowa. The newly formed Central Iowa Chapter had indicated some interest in co-sponsoring the meeting. Jerry Phillips asked Sheila Hainlin and Kathy Gourley to investigate the feasibility of the Central Iowa Chapter so-sponsoring the Spring 1993 meeting.

Bill Anderson suggested southeastern Iowa as a possible meeting site. Dave Swinehart suggested Four Mounds Park in Dubuque as a possible meeting location.

Jerry Phillips appointed Yvonne Chadek, Karole Fuller, and Arlo Johnson to serve on a committee for the Annual Meeting. Phillips stated that he would appoint the committee chair after the meeting site had been selected.

In addition to planning the 1993 Annual Meeting, Phillips asked the committee to consider selecting Annual and Fall meeting sites for upcoming years. Selecting meeting sites a few years in advance would aid the Society's planning efforts.

**IX. Clarification on Election of Officers:** Kathy Gourley reported that in the past, the two Editors were elected in the same year, and the Secretary and Treasurer were elected in another year. This allowed the terms of Board members to be staggered, so that there was not a complete turnover in Board membership in any given year. Somewhere along the way, this cycle got disrupted and all four positions were voted on at the 1992 Annual Meeting. Following the old pattern, election of Editors occurred in 1980, 1983, 1986 and 1992, while the election of the Secretary and Treasurer occurred in 1981, 1984, 1987, 1990 and 1992. Kris Hirst moved that the Board direct the nominating committee to hold elections for the Secretary and Treasurer at the 1993 Annual Meeting. Mary Helgevold seconded. Motion carried.

**X. Membership Committee:** Jerry Phillips appointed a membership committee to explore ways of increasing the

Society's membership. The committee members are: Dave Swinehart (chairman), Ferrel Anderson, Dawn Snyder, and Roger Natte. Board members expressed a willingness to contact former members and encourage them to renew. Membership lists will be provided to the Board for this purpose. Deb Zieglowsky-Baker is working on a history of the Society, including an analysis of membership types. This information should be very useful for the Board.

**XI. Chapter Committee:** Jerry Phillips appointed a chapter committee to act as a liaison between the Society and local chapters. The committee members are: Mary Helgevold (chairwoman), Dennis Miller, Shirley Schermer and Bill Anderson. Local groups include the Northwest Chapter, Rowe Chapter (Glenwood), Central Iowa Chapter, Keyes Chapter, Black Hawk Chapter, and the Quad Cities Chapter. There used to be a chapter in the Ottumwa area, but Board members were unsure whether it was still active.

**XII. Committee Budgets:** Jerry Phillips requested that the Board authorize small budgets for the Membership Committee and the Chapter Committee. Committee chairs would authorize the expenditures of these funds. Yvonne Chadek moved that each committee be authorized to spend up to \$100. Dale Henning seconded. Motion carried.

**XIII. Annual Goals:** The Board discussed goals for this year. The following items were agreed upon:

- \* Participate in Archaeology Week
- \* Increase membership
- \* Get *Journal* published on time
- \* Develop stronger links with local chapters

Dale Henning moved that the above goals be those of the IAS for 1992. Yvonne Chadek seconded. Motion carried.

**XIV. Other Business:** The Board discussed ways of recognizing extended service to the Society. Several options were discussed. Mary Helgevold will look

into this matter, and take care of the details.

Dave Swinehart reported that OSA had received a letter from a man who had buried a half gallon bucket of projectile points 20 miles south of Waterloo 40 years ago. The man would like someone to excavate it.

Dave Swinehart reported that the 1992 Annual Meeting netted \$400.

**XV. Adjournment:** Dale Henning moved that the meeting adjourn. Dave Swinehart seconded. Motion carried. The meeting adjourned at 11:58 am.

Art Bettis of the Iowa Geological Survey, DNR, presented a talk on three important sites in central Iowa: the Cambridge site, the Buchanan site, and the Mary Jane alluvial fan site. Lithic artifacts from all three sites were similar in style to other artifacts associated with late Paleo-indian and/or Early Archaic cultures.

Kathy Gourley with the Iowa State Historical Society, Historic Preservation, will discuss the placement of Ft. ### PUBLIC EDUCATION, 1992

A tradition continued on Wednesday, April 15, 1992, when students, parent-chaperones, and teachers from Pekin Middle School led by social studies teacher Bill Anderson visited archaeological sites in southeast Iowa as part of an all day field trip. Bill (a newly elected IAS Board member) has conducted similar excursions for students and teachers in recent years. The group was accompanied by Lynn Alex of the Office of the State Archaeologist, who fielded questions at the Wever Terrace, the Malchow Mounds, and the Toolesboro Mounds and visitors center. Local Louisa County historian Ron Cross provided an overview of the history and archaeology of the Toolesboro locality. A final, non-archaeological, stop was made at the Mark Twain Louisa Division National Wildlife Refuge Center at Lake Odessa. The photo to the right shows part of the group at the Malchow Mounds.

On July 17 and 24 young campers at City Park in Iowa City conducted a mock excavation as part of "Time Capsule Camp" sponsored by the Johnson County Heritage Museum. The idea was the inspiration of Museum program coordinator Deb Dunn, who planned the two weeks of camp activities to include an exploration of life in pioneer and prehistoric times. As part of "Indiana Jones Day"—the final day for each one-week session—camp participants excavated and screened cardboard box sites filled with different "strata" of sand, soil, and cat litter to recover a sequence of artifacts and floral and faunal remains. The most recent activities in City Park were reflected in the uppermost assemblage in each box which included candy wrappers, balloons, and plastic objects. Progressively older remains consisted of crockery, candle sticks, bird bones, corn kernels, and ceramic and wooden beads. The lowest layers contained fossil seashells. Assistance in planning the sites and directing the excavation was provided by Lynn Alex of the OSA.

### ARCHITECTURAL HISTORIANS' ACTIVITIES

The OSA Highway Archaeology Program employs several architectural historians to evaluate standing structures in proposed road construction areas. Staff members report on some recent activities:

Jeffrey Durbin recently completed Phase I historic architectural surveys of Iowa Department of Transportation projects in western Iowa. Among the resources he recorded for the proposed U.S. 75 bypass of Sioux City is the KSCJ radio transmitter which is housed in a 1936 Art Deco-style building. Jeff has also written book reviews for the Pioneer America Society's journal *Material Culture*, and for the *SCA NewsJournal*, the journal of the Society for Commercial Archeology.

Raymond Tinnian recently completed fieldwork for an architectural history survey in Muscatine County. He also completed final revisions for an article published in October in *The Palimpsest*. He recently gave a presentation to the North Central Iowa Genealogical Association and compiled a comprehensive listing of a 605-page collection of documents from the

criminal files of Frank and Nathan Rainsbarger, characters in a celebrated 19th-century central Iowa murder and lynching.

Hugh Davidson completed architectural surveys in Bremer (Iowa 3 and U.S. 63), Jackson, and Dubuque counties (U.S. 52). Identification of the historic Washington Creamery (13-BM-25H) near Waverly led to preparation of a paper with Susan Snow on Iowa's historic 19th-century creameries. Hugh also completed a National Register nomination for the Clear Creek (IL) Friends Meeting-house (built 1875) and is writing a nomination for the Whittier Friends Meeting-house (built 1893), Linn County.

Marlin Ingalls completed surveys in Keokuk (Iowa 149) and Muscatine (U.S. 61) counties. He also test-excavated the "Old Dubuque Jail" for the Dubuque Museum of Art, which is currently housed in the building. Designed and built in 1857-58 by noted architect John Francis Rague, it is one of only three remaining Egyptian Revival public buildings in the United States and is listed on the National Register. Testing was conducted along the building's east side prior to construction of a handicapped ramp.

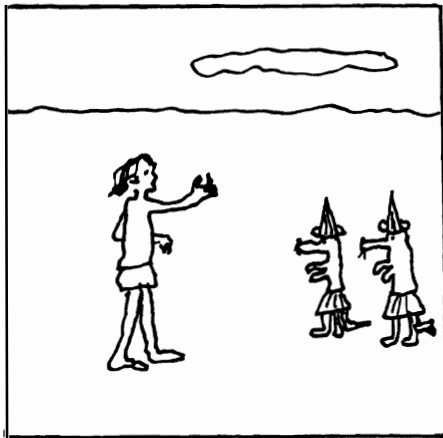
